I. Approval of Previous Meeting Minutes

Tara Allden made a motion to accept the minutes of December 8th with a minor typographic correction on page 2. Sydni Redmond seconded the motion, which carried.

II. Financial Report

Allen Conger reviewed the year end financials and the 2021 proposed budget materials previously distributed. Mr. Conger noted the growth in membership. Ms. Graham will make suggested adjustments and wait for more information on adding the costs for the possible Stream Quantification Tool (SQT) Workshop support for the February meeting. Mr. Conger requested that the Executive Committee email information to the whole Committee on any conferences that may be appropriate for the SCMA to participate, sponsor or exhibit.

III. Quarterly Meeting

- The questions posed during the December Quarterly meeting on official responses and discussion making were discussed. More issues are being delegated to the other committees. Mr. Conger acknowledged that it takes a while to get a letter through the Executive Committee, getting comments from membership would slow the process too much. Ms. Knight-Meng suggested emailing members to solicit input when time allows. Members may become active in committees if they wish to contribute to current topics of discussion. The SCMA letters are posted on the website and in the member area. Ms. Redmond recommended email the letter to members once the letter has been submitted.

- River Mechanics has submitted their Voting Membership dues.

V. Old Business

- David Wilson emailed Mr. Conger in response to the letter to the USACE, *Charleston District Interagency Regulatory Team, Mitigation Banking and Regulatory Compliance*. The email stated that he would respond, since the letter primarily addressed his area of work. Mr. Conger will share any responses with the Committee, but nothing official has been received at this time.
- Daniel Johnson will speak with DNR to gather more information on the SQT workshop including location, anticipated actual costs, and agenda.

VI. New Business

- The Technical Committee sent a response to the Proposed South Carolina SQT as solicited by DNR. The SCMA's request to participate in the steering committee was denied. Mr. Johnson will discuss this and explain the benefits of having practitioners on the committee when he speaks to her about the workshop.
- The Partnership Committee leadership will meet to establish a mission statement and set a schedule.
